
PERCENTAGE OF REAL PRIVATE-SECTOR JOBS GAINED/LOST BETWEEN 2007 AND 2012

Federal contract-funded private-sector jobs were estimated by calculating federal-contract spending as a percentage of the sum of federal-contract spending and nonagricultural private-sector GDP and multipying that percentage by total nonfarm private-sector payroll jobs.
