## A Snapshot of Wyoming Regulation in 2018


99,566 Restrictions, 5.4 Million Words, and 7 Weeks to Read

It would take an ordinary person more than two and a half years to read the entire US *Code of Federal Regulations* (CFR), which contained more than 104 million words in 2016.<sup>1</sup> The sheer size of the CFR poses a problem not just for the individuals and businesses that want to stay in compliance with the law but also for anyone interested in understanding the consequences of this massive system of rules. States also have sizable regulatory codes, which add an additional layer to the large body of federal regulation. A prime example is the online version of the 2018 *Wyoming Administrative Code* (WAC).<sup>2</sup>

Researchers at the Mercatus Center at George Mason University developed State RegData, a platform for analyzing and quantifying state regulatory text.<sup>3</sup> State RegData captures information in minutes that would take hours, weeks, or even years to obtain by reading and counting. For example, the tool allows researchers to identify the industries that state regulation targets most by connecting text relevant to those industries with restrictive word counts. Known as regulatory restrictions, the words and phrases *shall, must, may not, prohibited,* and *required* can signify legal constraints and obligations.<sup>4</sup> As shown in figure 1, the three industries with the highest estimates of industry-relevant restrictions in the 2018 WAC are utilities, chemical manufacturing, and construction of buildings.

State RegData also reveals that the WAC contains 99,566 restrictions and 5.4 million words. It would take an individual about 298 hours—or more than 7 weeks—to read the entire WAC (assuming the reader spends 40 hours per week reading and reads at a rate of 300 words per minute). By comparison, there are more than 1.08 million restrictions in the federal code.<sup>5</sup> Individuals and businesses in Wyoming must navigate these different layers of restrictions to remain in compliance.



#### Figure 1. Top 10 Industries Targeted by Wyoming State Regulation in 2018


The titles of the WAC are organized based on the state agency overseeing the rules. Figure 2 shows that the title of the WAC associated with the Department of Workforce Services contains more than 33,500 restrictions. By this measure, this is the biggest regulator in Wyoming. Coming in second is the Department of Environmental Quality, with more than 14,000 restrictions.

Federal regulation tends to attract the most headlines, but it is important to remember that the more than 104 million words and 1.08 million restrictions in the federal code significantly understate the true scope of regulation in the United States. States like Wyoming write millions of additional words of regulation and tens of thousands of additional restrictions. State-level requirements carry the force of law to restrict individuals and businesses just as federal ones do.

Researchers are only beginning to understand the consequences of the massive and growing federal regulatory system on economic growth and well-being in the United States.<sup>6</sup> Meanwhile, the effects of state regulation remain largely unknown. If this snapshot of Wyoming regulation in 2018 is a good indicator, then the states are also active regulators, suggesting that the full impact of regulation on society is far greater than that of federal regulation alone.
