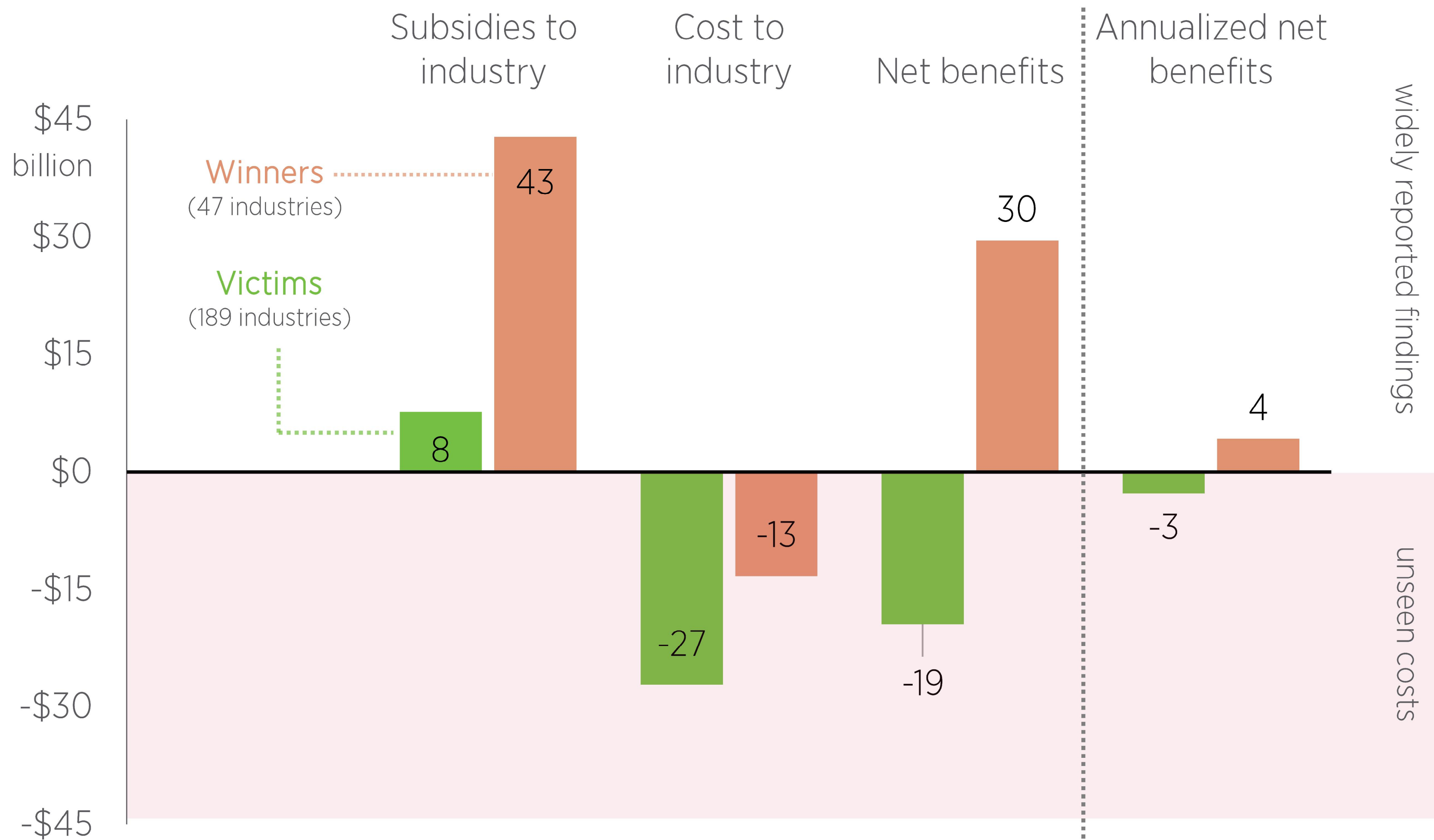


No Free Lunch: Ex-Im Winners and Losers
